#### International


- Looking into the possibility of shipping New Zealand orders from the Australian Warehouse as opposed to shipping from our USA Warehouse. Update to follow.

### Q & A

- IT Department currently checking to ensure the sponsor information will be available on the new member emails.
- Please ensure those Swedish distributors who had shake on their autoship have changed the order to a different product until the shake is available.
- Under the "Buy Retail" section of EU websites, only the XPower Squares and Nuggets are showing available. IT Dept. working to get this resolved in a timely manner to show Omega and XProtein Shake as well.
- Google Translate on website is not completely accurate; we are looking into getting the Back Office translated into Norwegian first. Pricing underway.
- We are currently reviewing candidates for a European Manager who has had previous Network Marketing experience and knows the German laws well.
